Vulnerability Index


What is it?

 "Tool for identifying and prioritizing the street homeless population for housing according to the fragility of their health" – 100,000 Homes Campaign

What do the scores mean?

- People living homeless have a 3 to 4 times greater chance of dying prematurely
- Higher the Score → Increased Chance of Premature Death

Vulnerability Index



How is it Calculated?

- Homeless more than 6 months
 - 3+ hospitalizations in a year
 - 3+ ER visits in last 3 months
 - Age 60 or older
 - Cirrhosis of the liver
 - End-stage Renal Disease
 - History of frostbite, immersion foot, or hypothermia
 - HIV+/AIDS
 - Tri-morbidity
 - Combination of mental health, physical health, and substance abuse issues

Approximately 50 volunteers


Where?

 - Most surveys administered at Glory Hole



69 People (54 Male, 15 Female)


Age of Surveyed Participants by Gender




Ethnic Background of Survey Participants







Juneau Housing First Project

Features:

- 32 Permanent Supportive Housing Units
 - Most Vulnerable Individuals are Prioritized
- Front Street Community Health Center
 - Primary Health Care, Mental Health Care, Substance Abuse Treatment
- On-Site Laundry Facilities, Kitchen and Dining Space, Garden Space
- Staffed and Secure Front Desk Area

Housing First

- 87 ER Trips in Last 3 Months
- 55 Hospitalizations in Past Year
- Jailed 435 total times collectively
- 35 out of 40 reported they wanted to live in housing first units

40 Vulnerable - 32 HF Units = 8 Unhoused

80% reduction
